Sweet and Smoky Chili

Ingredients:

- 2 cans black beans - undrained
- 1 can kidney beans - drained

All Users who are part of the Metropolitan Water Reclamation District of Greater Chicago (MWRD)'s system are required to file an annual RD-925 by February 20th each year.

This document is a regulatory and financial statement that must be signed, notarized, and submitted with payment (if required) for the balance payable for User Charge or sewer surcharge fees.



If Gabriel completes your facility's RD-925, the information below is required:

- Payments to MWRD in 2018
- City or Village Water Bills for 2018
- Weekly Meter Readings, if applicable
- Tax Statements
- MWRD Sampling Data

- 1 lb chicken thighs

- 4) Serve with cheese, sour cream, etc. And enjoy!

Tier II Hazardous Chemical Reports Due March 1st



Each year, facilities with hazardous chemicals on hand must submit Tier II (Community Right-to-Know) forms by March 1st for the previous calendar year. The Illinois Emergency

Management Agency (IEMA) requires submission electronically using their <u>Tier II Manager program</u>. Printed copies must also be submitted to the facility's Local Emergency Planning Committee (LEPC) and fire department.

Submission of Tier II form is required under Section 312 of the Emergency Planning and Community Right-to-Know Act of 1986 (EPCRA). The purpose of this form is to provide State agencies, local officials, and the public with specific information on potential hazards. This includes the locations and amounts of hazardous chemicals present at your facility during the previous calendar year.

Tier II reports must include:

- Details of the types and quantities of chemicals stored on site, above reporting thresholds. Most chemicals have a minimum reporting threshold of 10,000 pounds. Extremely Hazardous Substances (EHSs) must be reported above 1 - 500 pounds, depending on the <u>substance</u>. Any quantity of phosphorus, for example, must be reported on the Tier II forms.
- Type and location of storage container
- A detailed site plan that meets minimum mapping requirements
- Electronic Safety Data Sheets (SDSs)
- Emergency contact information

EPA updated its reporting requirements for some chemical types and quantities in 2017. Some companies who were

This holiday season, Gabriel's employees adopted 196 children to buy Christmas gifts for through the Department of Children and Family Services (DCFS), as well as students at Chicago


Jesuit Academy (CJA),

a full scholarship school serving underprivileged young men on the West side of Chicago.


The students at CJA received books, games, sports equipment, art supplies, and science kits as part of their
